2 [Telephone dialed, then ringing.]
3 UNIDENTIFIED MALE SPEAKER 1: If disconnect
4 the phone, it'll still ring.
5 UNIDENTIFIED MALE SPEAKER 2: Going to let
6 it keep ringing.
7 [Gap.]
8 [Ringing for a continued period of time.]
9 [Busy signal]
10 [Telephone dialed, phone company recording.]
11 [Telephone dialed, then ringing for a
12 continued period of time.]
13 GRAHAM: Test one, two, three. Hello?
14 Hello? Why don't you --
15 JOHN-3: Hello?
16 GRAHAM: Hello? This is -- who is this
17 speaking?
18 JOHN-3: This John Hylar.
19 GRAHAM: John Hyslan (sic). Are you one of
20 the negotiators?
21 JOHN-3: Yeah. Who's this?
22 GRAHAM: My name is Graham. We're just
23 having a little bit of trouble with the phones for the
24 moment, so we're -- I just decided to tested it. You
25 want to speak to Steve?

1 JOHN-3: Yeah, if I could.

2 GRAHAM: All right. Just hang on one
3 moment. We -- he's been trying to get in contact with
4 someone too. So, just one moment.

5 JOHN-3: What's the problem with the phone,
6 Graham?

7 GRAHAM: We put two phones here on two
8 different lines. This is the one which David normally
9 speaks through and there's one downstairs which Wayne
10 speaks on and -- we want to get the one downstairs to
11 going out. I'm just trying to get that one going at
12 the moment.

13 JOHN-3: What's going on in there this
14 morning, Graham?

15 GRAHAM: Well, Steve was just giving a bit
16 of a study. Sorry. I'm just a bit out of my breath.
17 Would you -- if you'd like to just hang on a minute
18 I'll go get Steve for you.

19 JOHN-3: Yeah. Did, did you hear a ringing
20 though, Graham?

21 GRAHAM: No, I didn't.

22 JOHN-3: You didn't hear the phone ringing?

23 GRAHAM: No. Has -- have you been trying to
24 get through for some time?

25 JOHN-3: Yeah, we have.

1 GRAHAM: Well, I'm, I'm, I'm terribly sorry
2 about that. I'm just -- I just spent the last few
3 minutes trying to get the thing going. But at least,
4 least we've got through -- contact now.

5 JOHN-3: Well --

6 GRAHAM: Just, just hold on a minute. I'll
7 go get Steve for you. Okay?

8 JOHN-3: All right.

9 GRAHAM: Okay.

10 (Pause.)

11 STEVE: Hello?

12 JOHN-3: Steve.

13 STEVE: John.

14 JOHN-3: How are you?

15 STEVE: Not bad. How are you doing?

16 JOHN-3: I'm doing okay. We're ready to get
17 going today, huh?

18 STEVE: I'm disappointed. This crazy -- I
19 went down-- I was down at the other phone and the
20 thing was deader than a doornail. We're trying to
21 work on it. And then this one was dead. I'm amazed
22 you got through even. Because I picked it up and
23 someone else, and the thing was dead. So, I started
24 --

25 JOHN-3: What --

1 STEVE: -- wondering if it wasn't a line
2 outside or what.

3 JOHN-3: What's the matter with the phone,
4 Steve? Did you --

5 STEVE: I, I don't know.

6 JOHN-3: -- hear it ringing?

7 STEVE: No. In fact, the one that I usually
8 use -- I was going to bring a number of people there
9 to talk with you today, and I got there with them and
10 here the crazy thing wasn't working. So, I -- they --
11 they're working on it and looking at it now. They say
12 the line is dead. So, they're trying to figure out
13 what's going on. And then they -- we went up to this,
14 this phone here and found out that it was dead. So,
15 I'm kind of surpris-- and that was only minutes ago.

16 JOHN-3: Steve, what, what's the problem
17 with it? Do you know?

18 STEVE: Not yet. He's still working on --
19 you know, like he -- what he's doing, we've got a guy
20 that's tracing that right from the beginning to see if
21 it, if it -- the line itself is hot or dead. So, I
22 told him well, get on it so we can get going with this
23 thing.

24 JOHN-3: Steve --

25 STEVE: I -- yeah?

1 JOHN-3: -- in, in that case, we ought to
2 keep somebody near each phone, because it's critical
3 that we keep in contact today.

4 STEVE: Right.

5 JOHN-3: Especially today. Okay?

6 STEVE: Okay. This is John-3 maybe?

7 JOHN-3: Yeah, you got it.

8 STEVE: Okay. Let's see. What happened at
9 to -- I thought Dolan told me he was going to be on
10 the phone today?

11 JOHN-3: He's not around here right now and
12 they asked me to come in and talk to you. He's
13 checking some things out with Mr. Jamarin at the
14 Courthouse.

15 STEVE: Okay. Yeah, I would like that.
16 There's a couple things I wanted to ask him still that
17 we were talking about. So, you know, as soon as he
18 can let him give me a call, would you?

19 JOHN-3: Well, I don't know when that's
20 going to be, Steve, so I think we -- you and I will be
21 talking here for awhile. And --

22 STEVE: Just, just a minute. Someone's
23 calling me. Just hang on one second.

24 JOHN-3: All right.

25 STEVE TO UNIDENTIFIED PERSON: Pardon?

1 UNIDENTIFIED PERSON TO STEVE: (Not
2 discernible).

3 STEVE TO UNIDENTIFIED PERSON: Are they --
4 I'm on the phone. They, they called now. I couldn't
5 get out because the line's been dead. I went down and
6 the other phone, it's dead, and even this one was
7 picked up five minutes ago and it was dead also. I,
8 I'm amazed that they got through. I'm talking with
9 John-3 right now.

9 UNIDENTIFIED PERSON TO STEVE: Well, what's,
10 what's happening, you know?

11 STEVE TO UNIDENTIFIED PERSON: I don't know.
12 That's -- they're trying to check it out right now.
13 I don't have any idea --

13 UNIDENTIFIED PERSON TO STEVE: (Not
14 discernible) called in?

15 STEVE: Had you tried to call us before
16 this, John?

17 JOHN-3: I called a couple times, Steve.

18 STEVE: And what happened?

19 JOHN-3: It just rang several times and no
20 one answered it. That's why it's critical that, that
21 somebody --

21 STEVE: No, I know.

22 JOHN-3: -- be near the phone.

1 STEVE: I realize that, John. Just a
2 minute.

3 JOHN-3: Yeah.

4 STEVE TO UNIDENTIFIED PERSON: Yeah, he said
5 he did call a couple times and it just rang, so that
6 means that there's something up with the lines. I
7 don't know what.

8 UNIDENTIFIED PERSON TO STEVE: (Not
9 discernible).

10 STEVE TO UNIDENTIFIED PERSON: I've got
11 Graham. He's looking at the other one right now and I
12 want him to look at this one too, check the line all
13 the way through to the phone.

14 STEVE: Yeah, it's strange, because --

15 UNIDENTIFIED PERSON TO STEVE: (Not
16 discernible).

17 STEVE TO UNIDENTIFIED PERSON: Pardon?

18 UNIDENTIFIED PERSON TO STEVE: Well, hang up
19 and try to call --

20 STEVE: All right. Let me -- hang up and
21 let me try to call you, and if I don't call -- if you
22 don't hear from me in one minute, give me a call back,
23 John.

24 JOHN-3: All right.

25 STEVE: Okay. Hang on.

JOHN-3: Hello?

STEVE: Hello. John?

JOHN-3: Yes, Steve.

STEVE: Okay. Well, it's working now. I don't understand. At least this one is. I don't -- the other one isn't still. And it's in a better location where I can have more people on the line. That's why I was hoping to use it. Yeah --

JOHN-3: Steve, when we finish this conversation, remind me, I'm going to call you back and you check it out and see if it comes in. And then if you don't --

STEVE: Well, why don't --

JOHN-3: -- get any --

STEVE: -- let's do it right now or -- so I don't have to worry about at least this phone. Call me right back and --

JOHN-3: All right.

STEVE: -- and if I don't hear you in, in one minute, I'm calling you.

JOHN-3: Good enough.

STEVE: Okay. Bye.

JOHN-3: Bye.

1 [Telephone dialed, then ringing.]

2 JOHN-3: Hello?

3 STEVE: Hello, John. Steve. Nothing
4 happened.

5 JOHN-3: Nothing, huh?

6 STEVE: Nothing.

7 JOHN-3: No ring at all?

8 STEVE: But this -- but you called just
9 minutes ago, right? And they answered the phone,
10 didn't they?

11 JOHN-3: Right.

12 STEVE: What is go-- I don't -- now, I --
13 that doesn't make sense to me. I don't understand it.
14 Okay.

15 JOHN-3: Well, Steve, why don't we do this.
16 It's im--

17 STEVE: Okay.

18 JOHN-3: -- imperative that we, we keep in
19 contact with each other. We can either leave the, the
20 line open today or we can call in every half hour or
21 every hour.

22 STEVE: No. John, I know -- look, if you
23 were around last -- yesterday and last night and you
24 heard the dialogue, the rapport, how it's been
25 working, you know, it's been going great. There's

1 nothing on either side that, that there's any -- no
2 problems. We're -- if you would have heard John Cox
3 through the night and so forth and --

4 JOHN-3: I'm aware of all of that.

5 STEVE: Okay. Good.

6 JOHN-3: Yeah.

7 STEVE: Good.

8 JOHN-3: So --

9 STEVE: So, you know, it hasn't changed with
10 us. So, you know, everything's fine now. You know,
11 I'm, I'm not going to be jumping on your bandwagon or
12 anything like that. You know, we're doing the best we
13 can and, and I'm just going to stay right at it. I
14 went to bed about 4 or 5 this morning, had a few hours
15 sleep, and I'm right at it again. So, you know, I
16 mean, like you say it's imperative --

17 JOHN-3: What --

18 STEVE: -- well, you know, I'm -- we're not
19 letting up either.

20 JOHN-3: What's going on in there today,
21 Steve?

22 STEVE: Okay. Right today, in fact I think
23 you're pretty quick, let -- I, I believe there's one
24 or two coming out right away. So, let me -- I'll even
25 get their names. I'll, I'll talk --

1 JOHN-3: Why don't you give them to me right
2 now so I can tell --

3 STEVE: Hang on. I'm leaving --

4 JOHN-3: -- these people here.

5 STEVE: -- the phone. I'm -- let me check
6 now, because I -- remember, now, I just have -- had a
7 little bit of sleep here and, and --

8 JOHN-3: Okay.

9 STEVE: -- all it was --

10 JOHN-3: That's fine.

11 STEVE: Hang on one -- hang on a second.

12 JOHN-3: I'll do it.

13 (Pause.)

14 STEVE: Okay. John?

15 JOHN-3: Yes, Steve.

16 STEVE: Okay. The ones that are coming out
17 within minutes will be Rita Riddle and Gladys Ottman.

18 JOHN-3: Gladys Ottman? Can you spell that
19 for me?

20 STEVE: I think it's, I think it's O-T-T-M-
21 A-N, I believe.

22 STEVE TO UNIDENTIFIED PERSON: Isn't it?

23 STEVE: Yes.

24 JOHN-3: Okay. Are they -- she, she's an
25 older woman also. Are they U. S. citizens?

1 STEVE: Rita is and Gladys, I believe, is
2 from Canada.

3 JOHN-3: Canada?

4 STEVE: Yes.

5 JOHN-3: Okay. Is -- have we had any
6 contact with her relatives?

7 STEVE: I don't believe so, from what -- I'm
8 pretty sure not. I don't think so.

9 JOHN-3: Okay.

10 STEVE: I don't remember -- in fact, I heard
11 that -- I was told, John, that I was to get back with
12 you people this morning, which I've been trying to do,
13 and it was left to us that there were messages left
14 for individuals here?

15 JOHN-3: Yeah. We do have some. I'll try
16 to get a hold of them, Steve, but --

17 STEVE: Okay. Yeah. And, and let me know
18 who they are, because I'll start getting people
19 together. I've already got together like Sherry and
20 Scott. I hear that there were messages for them?

21 JOHN-3: I, I'm not sure on that, but I'll
22 get them together and I'll get you an answer here as
23 soon as I can.

24 STEVE: So, Dolan, will he be around today
25 then?

1 JOHN-3: Steve, John Dolan has expressed to,
2 to me personally that he would like to be available
3 when, when all of you come out of there. And --

4 STEVE: Right.

5 JOHN-3: -- we're going to try to make that
6 happen, but it has to be soon. Okay?

7 STEVE: No, no, no. John, you've got --
8 there's something about you. I -- now, you're okay,
9 but you're extre-- I don't know if you know it, but
10 you come across extremely pushy. It doesn't help me.
11 It honestly doesn't help you.

12 JOHN-3: Steve, I don't --

13 STEVE: You -- lis--

14 JOHN-3: -- mean to be that way.

15 STEVE: -- listen, you use words like
16 imperative and, and, and so forth. I -- believe me,
17 I'm with you. But, you know, again, if you would have
18 heard the conversations, if you listen to them, you'll
19 -- I -- we won't have to go through this whole thing
20 all over again.

21 JOHN-3: We're going to work this out.

22 STEVE: All right.

23 JOHN-3: All right?

24 STEVE: Okay. So, right now --

25 JOHN-3: Me and you.

1 STEVE: Okay. These two are going to be
2 coming out and we're talking minutes now.

3 JOHN-3: Okay. You're going to call us and
4 let us know when they're ready to come out?

5 STEVE: Yes.

6 JOHN-3: All right.

7 STEVE: I'll call --

8 JOHN-3: And you say it's --

9 STEVE: -- I'll call for sure.

10 JOHN-3: And I just want to make sure that,
11 that it's within minutes, Steve.

12 STEVE: Yes, it is.

13 JOHN-3: Right?

14 STEVE: Yes, it is. Because I went and
15 checked just now and they -- they're getting ready
16 right now, so that means it won't only take them, you
17 know, but just a moment of time here and they'll be
18 right out the door.

19 JOHN-3: Okay. Steve, to help you on your
20 end --

21 STEVE: Okay.

22 JOHN-3: -- I've got some names. You got a
23 pen and a piece of paper there?

24 STEVE: Yes. Let, let me grab -- I do have
25 a pen.

1 STEVE TO UNIDENTIFIED PERSON: Would, would
2 you give me that pad right there, please? Right by
3 where the phone was sitting? Thank you.

4 STEVE: Okay. I got it here. Let's see.
5 Now to get this pen going. Okay. What do you have,
6 John?

7 JOHN-3: And if you have any problems with
8 the spelling, let me know. Okay?

9 STEVE: Okay.

10 JOHN-3: First, let me ask, any of the
11 people in there have any health problems right now?

12 STEVE: Well, you know, Judy, of course.
13 Scott. I think -- well, David.

14 STEVE TO UNIDENTIFIED PERSON: Is anyone
15 sick hereOR have any other kind of health problems
16 that you're aware of?

17 STEVE: Did you find out what Vicky's
18 condition was, the -- one of the older women that went
19 out last night? Do you know -- I mean --

20 JOHN-3: We're, we're going to check on that
21 and I'll give that for you as soon as I can.

22 STEVE: All right.

23 JOHN-3: Probably real soon here.

24 STEVE: Okay.

25 JOHN-3: How about Rita and Gladys? How

1 about they're health problems?

2 STEVE: They're both fine. They're both
3 healthy. They have no problems.

4 JOHN-3: How old is Gladys?

5 STEVE TO UNIDENTIFIED PERSON: How old is
6 Gladys? Find out. That's what I'm asking. How old
7 is Rita? Find out, please.

8 STEVE: You know, a lot of these people I, I
9 know by first names, so even the last names sometimes
10 escapes me. I've even -- most of the times I've not
11 even heard.

12 JOHN-3: Steve, is she middle-aged or --

13 STEVE: Yeah. Gladys is middle-aged. Rita
14 is in her 30s. Probably, I, I would guess, anywhere
15 between 33 to five or six, somewhere in there.

16 JOHN-3: Okay. And Gladys is middle-aged?

17 STEVE: Yeah. Yeah. She would be in her
18 50s, late 50s maybe.

19 JOHN-3: Okay. Steve, have you got a pen
20 and a piece of paper there?

21 STEVE: Yes, I do.

22 JOHN-3: Okay. Like -- let's see. How
23 about cars? Do they have cars?

24 STEVE: Rita does. She's got a -- about an
25 '84 or '85 Prelude, but I don't know what the

1 condition is because Friday the tank went into it.
2 So, I don't know if it just did cosmetic damage or --
3 it would seem --

4 JOHN-3: Okay.

5 UNIDENTIFIED PERSON TO STEVE: (Not
6 discernible).

7 STEVE TO UNIDENTIFIED PERSON: They're how
8 old?

9 UNIDENTIFIED PERSON TO STEVE: 35 and (not
10 discernible).

11 STEVE TO UNIDENTIFIED PERSON: Oh, really?

12 STEVE: 35 and 67. So, Rita, of course, is
13 35 and Gladys is 67.

14 JOHN-3: Okay. So, Rita's car, you're not
15 sure whether it's drivable or not?

16 STEVE: It may, it may be. She --

17 JOHN-3: Okay.

18 STEVE: I think she would definitely like to
19 take it out or use it, if it's possible.

20 JOHN-3: Yeah. That's what I was thinking.
21 We can --

22 STEVE: Yeah.

23 JOHN-3: -- we can work on that. Okay?

24 STEVE: Okay. That would be great.

25 JOHN-3: Okay. Can you tell me where it is

1 and what color it is?

2 STEVE: It's a red car and it's -- let's
3 see. I guess it would be on the south side of the
4 building.

5 JOHN-3: Okay.

6 STEVE: When you come ar-- when a lot of
7 times the Bradleys enter the property through that
8 gate, they come around -- it bends around. It's that
9 corner that's closest to them as they come around the
10 corner. That --

11 JOHN-3: Is --

12 STEVE: -- end of the building. There's --

13 JOHN-3: Oh, okay.

14 STEVE: -- there's a red Prelude right there
15 by the side of that window, or pretty close.

16 JOHN-3: All right. All right. When, when
17 we -- they're ready here. I'll talk to her personally
18 or you can --

19 STEVE: Okay.

20 JOHN-3: -- pass the message. Steve, let me
21 give you these names --

22 STEVE: All right.

23 JOHN-3: -- before I forget about it. Okay?

24 STEVE: Okay. Sure.

25 JOHN-3: Family members of -- who have

1 called in, Ursula Gehrman.

2 STEVE: Okay.

3 JOHN-3: G-E-H-R --

4 STEVE: Yes. I know who she is even.

5 JOHN-3: -- M-A-N-N.

6 STEVE: She's from Hawaii.

7 JOHN-3: Okay. Galenda Ganem, G-A-N-E-M.

8 STEVE: Oh, but -- Belinda?

9 JOHN-3: G-A -- G as in golf.

10 STEVE: Okay.

11 JOHN-3: A, Adam.

12 STEVE: Uh-huh.

13 JOHN-3: L-E-N-D-A. And then the last name
14 I've got is G-A-N-E-M, as in Mike.

15 STEVE: Okay.

16 JOHN-3: Let's see. The next one is Linda
17 Champion.

18 STEVE: These have call-- I mean, see --
19 these are messages, I, I'm aware, that have come in
20 already and tapes. Have they brought in more
21 messages? Is that it or --

22 JOHN-3: Some of -- you know, they may be
23 repeats. I'm not sure, Steve.

24 STEVE: Okay.

25 JOHN-3: The next one is somebody that I've

1 personally talked to.

2 STEVE: Okay.

3 JOHN-3: Is Sue Johnson.

4 STEVE: That's my sister.

5 JOHN-3: Right.

6 STEVE: All right.

7 JOHN-3: Right. And she's a very nice
8 woman, Steve.

9 STEVE: Okay.

10 JOHN-3: She's concerned about you.

11 STEVE: Well, definitely. She always has
12 been.

13 JOHN-3: Yeah. And I, I think John
14 mentioned yesterday that the attorneys are -- have a
15 good reputation.

16 STEVE: Okay.

17 JOHN-3: All right? Next one, Joe S-A-N-T-
18 O-Y-O.

19 STEVE: Joe Santoya (sic)?

20 JOHN-3: Santoyo.

21 STEVE: Some-- is that what -- I guess so.

22 JOHN-3: Got it?

23 STEVE: Yeah.

24 JOHN-3: Okay. Solomon Malcolm, Junior.

25 STEVE: Okay.

1 JOHN-3: Next one, Gloria Hootman, H-O-O-T-
2 M-A-N.
3 STEVE: Okay. Okay.
4 JOHN-3: Next one, Karen Doyle.
5 STEVE: Okay.
6 JOHN-3: The next one, Herman Williams.
7 STEVE: Oh, I know who that is now or who
8 they're --
9 JOHN-3: I'm not sure, but we can always
10 check on it --
11 STEVE: Right.
12 JOHN-3: -- Steve, when we have a question
13 on it. All right?
14 STEVE: Okay.
15 JOHN-3: Next one, Denise Johnson.
16 STEVE: All right.
17 JOHN-3: Next one, Kim Lambert.
18 STEVE: All right.
19 JOHN-3: Okay. Albert Vaega, but it's an A-
20 E-G-A?
21 STEVE: Yeah. Neil, your broth-- where's
22 Neil? Okay. His brother Albert has left a message
23 for him.
24 JOHN-3: Who is it, Neil Vaega in there?
25 STEVE: Yeah.

1 JOHN-3: Okay. Next one is Ruth Mosher, M-O
2 S-H-E-R.
3 STEVE: Right. That's Sherri Jewell's
4 mother.
5 JOHN-3: Is that Carrie Jewell's mother
6 also?
7 STEVE: Grandmother.
8 JOHN-3: Okay. Next one, Michael Sommers.
9 STEVE: Hmm. Okay.
10 JOHN-3: Next one is Mary Jones.
11 STEVE: Just a minute.
12 STEVE TO UNIDENTIFIED PERSON: Could you get
13 out of the light there? Thank you.
14 STEVE: Okay. Mary Jones.
15 JOHN-3: You got that one, Steve?
16 STEVE: Yeah.
17 JOHN-3: Okay. The next one is Samuel
18 Henry.
19 STEVE: Yeah.
20 JOHN-3: Okay. Sharon Clark Kidd, K-I-D-D?
21 STEVE: K-I-D-D. Okay. Got it.
22 JOHN-3: All right. And there's another one
23 here, and I'm not sure if this is a misspell or not,
24 but it's N-E-S-E is what I've got.
25 STEVE: N-E-S-E. Nese. Oh, yes.

1 JOHN-3: Vaega.
2 STEVE: Yep. Okay. Is that it?
3 JOHN-3: Okay. And then the tapes that have
4 gone in are your sister's --
5 STEVE: Okay.
6 JOHN-3: -- Nese's --
7 STEVE: Right.
8 JOHN-3: -- Ursula Gehrman's --
9 STEVE: Right.
10 JOHN-3: -- Ruth Mosher --
11 STEVE: Okay.
12 JOHN-3: -- and Galenda Ganem.
13 STEVE: Okay. Got it. Okay. So, these --
14 this other list, this real long list you gave me, are
15 people that called in? Did they all leave messages?
16 JOHN-3: Yeah. These are people that -- a
17 list of people who have called or written to date.
18 STEVE: Okay. Would you know -- I was told
19 by one -- yourself or one of you -- I can't remember.
20 It's so long ago, I mean, in time, the way it passes.
21 I was told that a, a -- an acquaintance of mine or a
22 friend of mine from the University of Hawaii called
23 for me. His name was David Sheidler.
24 JOHN-3: I remember that call --
25 STEVE: You do?

1 JOHN-3: -- Steve, but I'm, I'm not sure --

2 STEVE: Did you take -- or did you take the
3 call yourself?

4 JOHN-3: No, I didn't, but I remember it
5 being discussed.

6 STEVE: Uh-huh. Okay. Yeah, the reason I
7 was wondering, I was still trying to figure out, you
8 know, when I come out if there's a way -- did he leave
9 a phone number, if I could contact him of, of any way
or --

10 JOHN-3: We can work on it, Steve. You
11 know, you'll --

12 STEVE: All right.

13 JOHN-3: -- be able to call him anyhow.

14 STEVE: Really?

15 JOHN-3: You know that and I --

16 STEVE: Not if I --

17 JOHN-3: -- know that.

18 STEVE: -- not if I don't have a phone
19 number. I mean, I don't know -- I --

20 JOHN-3: We'll --

21 STEVE: -- can I --

22 JOHN-3: -- we'll get it for you.

23 STEVE: All right.

24 JOHN-3: All right?

1 STEVE: Okay.

2 JOHN-3: Steve, when Rita and Gladys come
3 out --

4 STEVE: I'm going to give you a call.

5 JOHN-3: Well, no. I just want to
6 explain --

7 STEVE: Okay.

8 JOHN-3: -- this to you.

9 STEVE: All right.

10 JOHN-3: When they come out, drive to the
11 end of the driveway.

12 STEVE: Okay.

13 JOHN-3: Okay? And go straight across that
14 road out there.

15 STEVE: Okay.

16 JOHN-3: And just park right across the
17 road.

18 STEVE: Like in -- like go across the road
19 into the, the property that's across the road. Is
20 that what you're saying?

21 JOHN-3: You got it.

22 STEVE: All right.

23 JOHN-3: On the left side as they're heading
24 up that way.

25 STEVE: Okay.

1 JOHN-3: Okay? So, they just --
2 STEVE: All right.
3 JOHN-3: -- drive up, go across the road,
4 and just park on the left. And they'll instruct them
5 the same way as we have before.
6 STEVE: Okay. Very good.
7 JOHN-3: All right. Now, it's got to be
8 pretty quick, because we're going to call them in to,
9 to --
10 STEVE: Right. Yes.
11 JOHN-3: Hold on one second.
12 STEVE: Okay.
13 JOHN-3: Hold on one --
14 STEVE: All right.
15 JOHN-3: -- second, Steve. I'm just getting
16 a message here.
17 STEVE: Okay.
18 (Pause.)
19 JOHN-3: Steve?
20 STEVE: Yes.
21 JOHN-3: What they just told me is have her
22 drive to the normal pickup spot. Do you know where
23 that is? I haven't been out there so --
24 STEVE: I believe --
25 JOHN-3: -- I don't know where it is.

1 STEVE: -- I believe it's by -- I think
2 they've been dropping things off inside the complex
3 area -- I mean, inside the gate by a tree on the left,
4 I think right up th-- in that area. So, they have --
5 JOHN-3: Okay.
6 STEVE: -- to drive right about there and
7 stop maybe --
8 JOHN-3: Yeah. And, and there will be a
9 vehicle there. Okay?
10 STEVE: Okay. Their vehicle already will be
11 waiting.
12 JOHN-3: Right.
13 STEVE: Okay.
14 JOHN-3: Okay?
15 STEVE: And I, and I will call you right
16 back when they're about ready to go out the door and
17 get in the car then.
18 JOHN-3: Because of this phone problem,
19 Steve, you've got to --
20 STEVE: Yeah.
21 JOHN-3: -- call me right back. Okay?
22 STEVE: I, I will.
23 JOHN-3: Okey-doke.
24 STEVE: Okay.
25 JOHN-3: Bye.

1 STEVE: Bye.

2 *****

3 JOHN-3: Hello?

4 STEVE: Hello. John?

5 JOHN-3: Yes, Steve?

6 STEVE: Yeah, they're having -- I think
7 they're going to -- I -- it's almost apparent now that
8 she's not going to be able to use the car. I guess
9 there has been transmission damage from the -- you
10 know, it being shoved around and I think that car is
11 inoperable.

12 JOHN-3: Steve, are -- is there any other
13 car that she could drive out of there?

14 STEVE: It, it -- you know, they're so shot-
15 up full of bullet holes. They got flat tires. The
16 one that they were using in the beginning, say back a
17 couple weeks ago, that's one out of gas. Even it has,
18 you know, the window, it, it's actually -- you know,
19 it's got glass all over the seats. How about if they
20 -- I guess, that they just walk out wherever that --
21 you know, would be acceptable?

22 JOHN-3: They both can walk all right --

23 STEVE: Yeah.

24 JOHN-3: -- Steve?

25 STEVE: They can. They can.

1 JOHN-3: Okay.

2 STEVE: Even though the one's 67, she's
3 healthy and, you know, they take walks. They used to
4 take walks daily. So, yeah, they're okay.

5 JOHN-3: Okay. Why don't we have them do
6 the same thing. Are they ready to go out now?

7 STEVE: Yeah. They're -- in fact, they're
8 pretty near the door. I was still up here talking to
9 a couple more people, so I didn't realize that they
10 were already apparently at the door. Maybe they were
11 going to get something to drink, but other than that
12 they are ready to come out and walk up to the gate or
13 whatever they could do.

14 JOHN-3: Okay. Can you just check on that?
15 See if, if they're ready to go out the --

16 STEVE: Okay.

17 JOHN-3: -- door. Leave, leave us on the
18 hook here together.

19 STEVE: Okay. Hang on then and I'll -- and
20 I'm still hoping that we can get the other phone
21 going, because it's, it's closer to that door. So --

22 JOHN-3: Okay.

23 STEVE: Hang on a minute.

24 JOHN-3: All right.

25 (Pause.)

1 UNIDENTIFIED FEMALE SPEAKER: Hello?

2 JOHN-3: Hello.

3 UNIDENTIFIED FEMALE SPEAKER: Hi. Steve has
4 the phone working downstairs now. You can talk to him
5 on that phone. Okay?

6 JOHN-3: Okay. Now, is -- could you just
7 ask him to call me from that phone?

8 UNIDENTIFIED FEMALE SPEAKER: To call you?

9 JOHN-3: Yeah.

10 UNIDENTIFIED FEMALE SPEAKER: Okay.

11 JOHN-3: Okay?

12 UNIDENTIFIED FEMALE SPEAKER: I'll, I'll
13 hang it up. Okay.

14 JOHN-3: Okey-doke.

15 UNIDENTIFIED FEMALE SPEAKER: Okay. Bye.

16 JOHN-3: Bye.

17 *****

18 STEVE: John?

19 JOHN-3: Yes, Steve?

20 STEVE: Yeah, I've got a new line here
21 apparently. The other one is -- for some unknown
22 reason, it's totally dead. He tried to check
23 everything on it, so we can't just pick up the phone
24 anymore. I just had to dial out. But it's okay. The
25 two women, they're ready to come out the door now.

1 JOHN-3: Okay. Same as, same as before,
2 Steve.

3 STEVE: Yeah.

4 JOHN-3: And --

5 STEVE: I'll keep -- are the -- so, the
6 Bradleys will come about halfway? Is that the idea or
7 --

8 JOHN-3: Yeah, the, the same way that Brad
9 and Kevin and --

10 STEVE: Okay.

11 JOHN-3: -- the others were. Okay?

12 STEVE: Okay. So, they'll come driving up.
13 As soon as they do, the two women will come walking
14 out.

15 JOHN-3: Yeah. That's --

16 STEVE: Okay.

17 JOHN-3: -- fine.

18 STEVE: Okay. They're ready.

19 JOHN-3: Okay. And Steve --

20 STEVE: Yeah?

21 JOHN-3: -- what'll -- I'll do is, as soon
22 as they're, they're in, in the Bradley and as soon as
23 they're okay --

24 STEVE: Okay.

25 JOHN-3: -- I'll give you a buzz right back.

1 STEVE: Thank you.

2 JOHN-3: And you -- what, what number?

3 STEVE: I don't know what the number is
4 here.

5 JOHN-3: But I mean what phone?

6 STEVE: Oh, I think it's 5979 is what it
7 used to be. I don't know what it might be now.

8 JOHN-3: Yeah, but, I mean, whose phone are
9 you on?

10 STEVE: Wayne Martin's.

11 JOHN-3: Wayne's.

12 STEVE: Yeah.

13 JOHN-3: Okay.

14 STEVE: Okay.

15 JOHN-3: Good enough.

16 STEVE: Talk to you when you call.

17 JOHN-3: Okey-doke.

18 STEVE: Thank you.

19 JOHN-3: Bye.

20 STEVE: Bye-bye.

21 *****

22 JOHN-3: Hello?

23 STEVE: Hello, John?

24 JOHN-3: Yeah.

25 STEVE: Yeah. I just was told that -- to

1 make a correction here. I guess the number was 863-
2 5252, whatever line that would be now. I'm not sure.

3 JOHN-3: Okay. We'll figure it out, Steve.

4 STEVE: Okay. Thanks.

5 JOHN-3: But, but, listen, if you --

6 STEVE: Yeah.

7 JOHN-3: -- stand right by there, I'll, I'll
8 call you right back --

9 STEVE: All right.

10 JOHN-3: -- and we'll make sure it's
11 working.

12 STEVE: Verify --

13 JOHN-3: Hold on -- hold, hold on one
14 second.

15 STEVE: Sure.

16 (Pause.)

17 UNIDENTIFIED MALE SPEAKER: -- out what his
18 number is.

19 JOHN-3: Steve?

20 STEVE: Yeah?

21 JOHN-3: Are you on Wayne's old phone or did
22 you bring another phone down -- cord down?

23 STEVE: Well, you mean the phone itself or
24 the line?

25 UNIDENTIFIED MALE SPEAKER: The line.

1 JOHN-3: The line.

2 STEVE: The line, it's -- see, there were
3 always two in here. One was called 5252. The other
4 was 5979.

5 JOHN-3: Okay.

6 STEVE: And, apparently, one of them for --
7 I don't know. It went dead totally. And, so, what he
8 did is pull the other cord, stuck it into the phone,
9 and it's now working, but it doesn't dial directly --

10 JOHN-3: Yeah.

11 STEVE: -- when you pick it up anymore, I
12 guess.

13 JOHN-3: Okay. Steve, let me just make sure
14 I can ring you now --

15 STEVE: Okay. I'll be right --

16 JOHN-3: -- so that --

17 STEVE: -- by the phone right now.

18 JOHN-3: Stand right by the phone, okay?

19 STEVE: Okay.

20 JOHN-3: And then --

21 STEVE: I'll do so. And if I --

22 JOHN-3: And then --

23 STEVE: -- don't hear from you within a
24 minute, I'll call you back.

25 JOHN-3: Within two minutes call me back,

1 okay?

2 STEVE: Okay. Very good.

3 JOHN-3: All right.

4 *****

5 [Telephone dialed, then ringing.]

6 STEVE: Hello, John.

7 JOHN-3: Steve. Phone check.

8 STEVE: It works.

9 JOHN-3: All right. So, we got a -- we got
10 some communications. I'll call you. Send them out
11 and I'll call you as soon as they're, they're up the
12 road.

13 STEVE: Okay. Sounds good.

14 JOHN-3: All right.

15 STEVE: Thank you.

16 JOHN-3: Bye.

17 STEVE: Bye-bye.

18 *****

19 JOHN-3: Hello?

20 STEVE: Hello. John?

21 JOHN-3: Yes, Steve?

22 STEVE: So, what's happening?

23 JOHN-3: Are they out yet?

24 STEVE: The women have been waiting, but
25 there's no vehicle.

1 UNIDENTIFIED MALE SPEAKER: Oh --

2 JOHN-3: No. Have them walk out there,

3 Steve, and then the vehicle is going to come up.

4 STEVE: Oh, okay. I thought you were --

5 JOHN-3: Okay.

6 STEVE: You said like the -- see, what

7 they've been doing is they've had the vehicle come

8 halfway and then they go out to them. That's why when

9 you said just like with Kevin and Brad, but so --

10 JOHN-3: Yeah.

11 STEVE: -- see, that's not like Kevin and

12 Brad.

13 JOHN-3: Yeah.

14 STEVE: Okay. So, you want them to what,

15 walk halfway out, then, and then the Bradley --

16 JOHN-3: Hold --

17 STEVE: -- will meet them?

18 JOHN-3: Hold on one second, Steve.

19 STEVE: All right.

20 JOHN-3: I'll get this confirmed and --

21 STEVE: All --

22 JOHN-3: -- then we'll start from here.

23 Okay?

24 STEVE: All right.

25 JOHN-3: Hang on.

2 JOHN-3: Hello? Hello?
3 [Telephone dialed, then ringing.]
4 STEVE: Hello?
5 JOHN-3: Hello.
6 STEVE: Hello. Strange connection here.
7 JOHN-3: I know it, Steve. What went on?
8 Is, is that at your end?
9 STEVE: Could, could you hear me, when I was
10 saying hello, hello, hello?
11 JOHN-3: No, I couldn't.
12 STEVE: Oh, okay.
13 JOHN-3: Yeah. I didn't get anyth-- that's
14 why I hung up and dialed again, Steve.
15 STEVE: I see. Okay. So, they're
16 apparently down there now or --
17 JOHN-3: Yeah.
18 STEVE: Okay.
19 JOHN-3: They just called me. It went
20 smooth. No problem.
21 STEVE: Great.
22 JOHN-3: All right?
23 STEVE: That sounds good.
24 JOHN-3: Okay.
25 STEVE: I just wanted -- I was talking to

1 David. I don't know if you realize, but he was up all
2 through the entire night right in through the morning,
3 and the guy is totally wiped out. And what I'm doing
4 right now, I'm just going to get a bite to eat. I
5 haven't eaten yet today, and I only had one meal
6 yesterday. But, anyway, I'm going to be eating now
7 and I'm going to continue -- I just started talking

1 STEVE: Yeah?

2 JOHN-3: Listen. I just want to be able --
3 if they come up with questions regarding the system
4 out here --

5 STEVE: Okay. I'll --

6 JOHN-3: You know.

7 STEVE: -- refer them to you. I'll tell --
8 what I'll do is -- how about me -- that I call and let
9 you talk to them. Would that help?

10 JOHN-3: That would be fine.

11 STEVE: Okay.

12 JOHN-3: I'll talk to any one of them.

13 STEVE: All right.

14 JOHN-3: And I'm not going to mislead them.
15 I just want to --

16 STEVE: Oh, right.

17 JOHN-3: -- you know, assure them that --

18 STEVE: If you have, too, any new messages
19 or anything like that, you let me know. You know,
20 I'll put, I'll put on anybody that, you know, that
21 messages or anything of that nature comes through for,
22 you know. Or if they have any questions, I'll call
23 you and, and stick them on the phone, which may be
24 even today, you know. Different ones are starting to
25 talk to me again and I'll just make a list and jot

1 down a few things and I'll tell them they can call
2 you. They don't ev-- well, they always know they
3 don't need me, of course, but they, they get the
4 feeling that, you know, I have a, a rapport with you
individuals. So.

5
6 JOHN-3: Yeah. Yeah. And you know, Steve,
7 I, I'm of the same opinion as, as John Dolan and John
8 Cox. They're both good friends of mine and we can
9 work this out today and it'll be a good day.

10 STEVE: Okay.

11 JOHN-3: All right? And we'll get some
12 people out and everybody will be happy. Okay? Are
13 other ready, ready to go now?

14 STEVE: Just one minute. No, there aren't.
15 In fact, I see David. He's laying down right now
16 and, and there's a few that want to talk to him still.
17 So, he has to open up a few things to them to answer
18 some of their questions. So, I just -- give it a
19 little rest now for just a few moments. I'm going to
20 eat. I'm going to be talking to them more so that
21 they can be prepared, and then he's going to be
22 talking to them. And it could be more. I don't even
23 know who. I know that right now he's not sleeping
24 yet, but he himself is, is talking to individuals even
25 now.

1 JOHN-3: David is?
2 STEVE: Yeah.
3 JOHN-3: Oh, okay.
4 STEVE: So, he --
5 JOHN-3: That's good.
6 STEVE: -- so he -- so, he hasn't had any --
7 remember, he hasn't been to sleep now for -- and, and,
8 you know, in his condition --
9 JOHN-3: I know you're working on it, Steve,
10 and --
11 STEVE: I'll tell you the truth --
12 JOHN-3: -- and we're going to --
13 STEVE: -- I'm worn out. I mean, I went to
14 bed like -- if, if you heard John, he -- the poor guy
15 was up for quite a long time with us, and I finally
16 went to bed. It was near 5:00.
17 JOHN-3: Okay.
18 STEVE: Okay. Just one second, John. I, I
19 -- someone's asking me a question, so I'll, I'll --
20 hang on the line just a minute here.
21 JOHN-3: All righty.
22 (Pause.)
23 STEVE: John?
24 JOHN-3: Yo.
25 STEVE: Yeah, there's, there's a major

1 request here, and that's the men -- see, we're -- as a
2 body -- as people that believe in the Bible, we're,
3 we're -- believe it or not, contrary to rumors and all
4 that, we're extremely modest, even when it comes to
5 dress and all the rest. And we're concerned because
6 we observed, as when the women Rita and Gladys,
7 because it's daytime, went out there, that they were
8 frisked over.

8 JOHN-3: Uh-huh.

9 STEVE: Do you have FB-- female FBI agents
10 that could --

11 JOHN-3: That's correct. We do.

12 STEVE: You do have?

13 JOHN-3: Yeah.

14 STEVE: Because any -- from -- in the
15 future, if we send out women, could they --

16 JOHN-3: Yeah.

17 STEVE: -- take care of that?

18 JOHN-3: Steve?

19 STEVE: Yes.

20 JOHN-3: They're -- women are searched by a
21 female agent. Okay?

22 STEVE: Okay. So, then -- but we saw --

23 JOHN-3: That -- but -- you know what, in
24 that stuff that they have on, you couldn't tell and I
25

1 | couldn't tell. I'll tell you that.

2 | STEVE: Right. But, no, we noticed a man,
3 | though, a, a male --

4 | JOHN-3: Yeah.

5 | STEVE: -- that was going over both of the
6 | females out front, so that's what our concern is. If
7 | you have a --

8 | JOHN-3: Yeah.

9 | STEVE: -- a female FBI agent that could do
10 | that?

11 | JOHN-3: Yep. There's, there's one out
12 | there.

13 | STEVE: Okay. Good.

14 | JOHN-3: Okay?

15 | STEVE: Thank you.

16 | JOHN-3: All right --

17 | STEVE: And I'll be --

18 | JOHN-3: -- Steve.

19 | STEVE: -- talking to you in awhile.

20 | JOHN-3: Listen, we'll get going in about an
21 | hour maybe?

22 | STEVE: Hopefully. But, you know, it -- I
23 | don't know for sure. But, you know, let me -- because
24 | I'm going to be talking, you know. I'm, I'm already
25 | tired and hoarse, but I'm not going to quit.

1 JOHN-3: All right. You keep working. I'll
2 keep --
3 STEVE: I have.
4 JOHN-3: -- working.
5 STEVE: I am.
6 JOHN-3: All right?
7 STEVE: Okay. I'll --
8 JOHN-3: We'll get it going.
9 STEVE: -- talk to you in awhile. Okay.
10 Bye.
11 JOHN-3: Bye.
