7 SHERRY: Hello, hello.
8 JOHN COX: Hello. This is John.
9 SHERRY: Hello.
10 JOHN COX: Can you hear me?
11 SHERRY: Vaguely.
12 JOHN COX: Who's this?
13 SHERRY: This is Sherry.
14 JOHN COX: Sherry. This is John. Is Steve
15 around?
16 SHERRY: Well --
17 JOHN COX: Oh. Never mind. Sherry. Don't
18 run off. I've got a message for you. This is John,
19 your friend.
20 SHERRY: John Cox.
21 JOHN COX: How are you?
22 SHERRY: Hi.
23 JOHN COX: How are you?
24 SHERRY: Fine.
25 JOHN COX: And I don't know if I passed it

1 on to you before about contact we had from your
2 mother. I'm just trying to contact a bunch of people
3 in there an let them know that some folks have called
4 and asked.

5 SHERRY: That's good. Did you just get on?

6 JOHN COX: I'm sorry.

7 SHERRY: Did you just get on?

8 JOHN COX: Well, I've been here for a while.

9 SHERRY: When did you get there?

10 JOHN COX: What time is it? 8:20. Around
11 6.

12 SHERRY: Well, that's good.

13 JOHN COX: What I wanted to tell you is she
14 indicated that she was in Texas for a while. Hoping
15 you'd come out please. Let me know you're okay. We
16 have a phone number to call her. She'll be in Texas
17 until Wednesday. She left a mobile telephone number
18 and a phone number where we can reach her. An 817
19 number. Where is that, do you know?

20 SHERRY: 817?

21 JOHN COX: Yeah.

22 SHERRY: That's here.

23 JOHN COX: Oh. Okay. It's been a long
24 time. So, we'll give her a call. We'll have somebody
25 give her a call and let her know that we talked to

1 you, we spoke to you, you're doing okay.

2 SHERRY: Yeah.

3 JOHN COX: Any message that you want passed
4 on to her?

5 SHERRY: Um --

6 JOHN COX: And I need something else from
7 you too kid. All this note says is mother. What's
8 her name?

9 SHERRY: Ruth Moser.

10 JOHN COX: Okay. Got you.

11 SHERRY: Yeah. Let's see. Have her read --
12 all mixed up -- have her read Mark 13.

13 JOHN COX: Okay. That's it?

14 SHERRY: Luke 21.

15 JOHN COX: Okay.

16 SHERRY: Yeah. Well, I'm glad you're back
17 on.

18 JOHN COX: Me too.

19 SHERRY: Yeah.

20 JOHN COX: Enjoy it.

21 SHERRY: Huh?

22 JOHN COX: I enjoy talking to you all.

23 SHERRY: One of these days I'll meet you
24 face to face.

25 JOHN COX: You will. You betcha. I'm

1 looking forward to it.

2 SHERRY: Well, I don't know where Steve is.

3 JOHN COX: Any other message for your mom?

4 SHERRY (aside): This is John Cox.

5 SHERRY: I think he's coming.

6 JOHN COX: Okay because I've got a bunch of
7 messages for other people and --

8 SHERRY (aside): I guess he's got a bunch of
9 messages. Yeah.

10 SHERRY: Here he is.

11 STEVE: John. It's a pleasure to hear your
12 voice. I'm serious. Oh, brother, I'm worn out.

13 JOHN COX: Oh, no. I'm going to let you get
14 a good night's sleep tonight.

15 STEVE: Yeah. I've been talking since
16 early. I mean I went to bed and I sat up there --
17 remember how you were talking with them and --

18 JOHN COX: No. I was doing a lot of
19 listening.

20 STEVE: That's true, John, you were.

21 JOHN COX: There was one principal talker
22 and I couldn't believe it that he had you and Rita
23 awake too.

24 STEVE: That's true. I was there until at
25 least 4, I think it was later, 5 by the time I turned

1 in. I slept for about 2 hours.

2 JOHN COX: Just goes to show you. We all
3 have our cross to bear.

4 STEVE: Well, this is it. Well anyway, the
5 whole day I've been trying to -- well, when I'm not on
6 the phone with John-3 --

7 JOHN COX: Listen. It sounds like it was a
8 very successful day.

9 STEVE: Not according to your commanders
10 John-3 and Byron. It sounded like it was a big flop.
11 David and I, by the time -- he passed out. You know,
12 because he, he was already working with more -- he
13 told me to go work with more people which I was doing.

14 JOHN COX: Between you and me and John-3 and

9 saying give me an opportunity to answer some of these
10 things. I've been around him, I've heard a lot. So,
11 I mean, I talked and talked and talked. I had as many
12 as somewhere between 30 and 40 sitting down.

13 JOHN COX: Is that right.

14 STEVE: Yeah.

15 JOHN COX: Oh great.

16 STEVE: And then they got the idea John is
17 saying we're supposed to send 30, 40 out. I don't
18 know where -- I says, look --

19 JOHN COX: That seems like a good idea.

20 STEVE: Well, yeah. I told them I agreed
21 with him. I didn't disagree with him at all. I
22 finally came to the place he was so adamant, I says,
23 what do you want me to grab one of these guys by the
24 neck and try to pull him out the door or something.
25 You know --

1 JOHN COX: No. they've got to listen to a
2 little Micah and a little Nam first. We understand
3 that.

4 STEVE: Well, that's it. But --

5 JOHN COX: What I wanted to touch base with
6 you tonight, and I hope you and David both get a good
7 night's sleep tonight, is, I mentioned it to David and
8 I guess I mentioned it to you before, that we've got
9 several people that have either written letters, have
10 contacted us, and we wanted to pass the word to folks
in there.

11 STEVE: Well, that sounds good.

20 contact and if they want to talk to me, I'll pass on
the messages. Okay?

22 JOHN COX: Jean Borst, B-O-R-S-T.

2 JOHN COX: I presume a female.

3 STEVE: Correct.

4 JOHN COX: Sandra Hardial, H-A-R-D-I-A-L.

5 STEVE: What's the last name?

6 JOHN COX: H, as in Henry, A-R-D, as in
dog --

7 STEVE: Harding?

8 JOHN COX: I-A-L.

9 STEVE: I-A-L. Oh, Hardial.

10 JOHN COX: I believe she is British.

11 STEVE: Yeah, she would be.

12 JOHN COX: Sandra, maybe, I don't know.

13 STEVE: Right, I remember the first name.

14 JOHN COX: And there is another Brit, I
presume, Mike Malcolm, Livingston Mike Malcolm.

15 STEVE: Livingston, okay, Livingston.

16 JOHN COX: Well, we got something from a
brother that said Livingston Mike Malcolm. Melissa
17 Morrison. She should be young, I guess. A young
18 girl.

19 STEVE: What's her name?

20 JOHN COX: Melissa Morrison.

21 STEVE: Okay. Melissa. Yeah.

22 JOHN COX: Got a couple messages for David

1 Thibodeaux, Marguerita Vega. I'm pronouncing that
2 right, huh? Scott Senobe. And Jeff Little. And I
3 gave you one last time, I guess.

4 STEVE: Well, the more the merrier. I don't
5 mind.

6 JOHN COX: Well, I know I told you that your
7 sister would be out here and a Wayne Peterson --

8 STEVE: Wayne Peterson?

9 JOHN COX: Who would be Judy's brother.

10 STEVE: Brother. He called or something or
11 what? Not quite called but --

12 JOHN COX: He didn't leave a phone number,
13 that's all. He just called to say hello, wants to
14 make sure everything is all right in there. That's
15 all that was about. But we've had no phone number so
16 I don't know. I don't know. We would have to try to
17 contact him somehow and then Shirley Putterman called.
18 That's Judy's mom.

19 STEVE: Right.

20 JOHN COX: Okay. And, yes, I do have a
21 number for Wayne, 608 area codes for both of them.
22 That number for Wayne is on the Shirley Putterman call
23 and there was an Earl Peterson.

24 STEVE: He called too?

25 JOHN COX: Called from Madison, Wisconsin.

1 the people that called are just calling to let folks
2 know that they're supportive.

3 STEVE: Is that it then? You don't have a
4 number for this David Scheidler from the University of
5 Hawaii, do you?

6 JOHN COX: I could probably find one. I
7 don't have it in front of me here. But, you know, if
8 there is some kind of message, I'm sure that we could
9 get it back.

10 STEVE: Okay. Thanks.

11 JOHN COX: If you can round up any of those
12 folks, I sure won't hassle you during the night and
13 let you get a good night's sleep.

14 STEVE: Okay. Let me do that. I'm going to
15 pass this around and have them, you know, whoever
16 wants to come here for the messages or to talk to you,
17 you know, that would be fine.

18 JOHN COX: How are things looking? Okay?

19 STEVE: Yeah, you know, there were until,
20 you know he fell asleep and --

21 JOHN COX: Well, maybe he'll get a good
22 night's sleep.

23 STEVE: Well, I'm hoping so. You know, I
24 actually -- he was awake right until, I think it was,
25 early afternoon. He never got any sleep, so --

10 | STEVE: And right after 9 we'll call or you
11 | can call or --

12 | JOHN COX: Sure. Sure.

13 | STEVE: I'll tell you what though, honestly,
14 | it's a pleasure to talk to you again, it really is.
15 | I've always enjoyed spending some time with you and --

16 | JOHN COX: Whether it's me or anyone else
17 | out here, we're all working towards the same thing.

18 | STEVE: Well, you know, there's different
19 | tactics, different psychologies and what you do helps
20 | me. I mean, you know, I'll tell you, it is hard. It
21 | really is. And I'm just going to keep right on going
22 | anyway but when I'm called back and forth to the phone
23 | every so many minutes and all that, it's like I'm
24 | getting absolutely nowhere. And like I had 30 to 40
25 |

1 people together, called to the phone, got back, there
2 was less than half of them still sitting there. You
3 know, they didn't wait. So --

4 JOHN COX: Well, I just wanted to get with
5 you early this evening so you can get a chance to

7 we can talk to them.

2 mean, it's hard on a person like you. I know it would
3 be. Especially if you don't buy it. I really -- I
4 sympathize with anybody that would sit for hours. If
5 you --

6 JOHN COX: Well, we've all been very
7 patient.

8 STEVE: Maybe you can keep a reserve in the
9 back of your mind when you start seeing things happen.
10 I'm not saying they're going to happen immediately,
11 but I don't know, I see something to these prophecies,
12 so --

13 JOHN COX: Hope so.

14 STEVE: Oh, yeah, you know that or I'd have
15 been out of here -- I'd have flow out of here long
16 ago.

17 But anyway --

18 JOHN COX: Sure, sure. But give us a call
19 and see if you can run down some of those folks for
20 us.

21 STEVE: Okay. We'll do it.

22 JOHN COX: Okay, thanks a lot.

23 STEVE: No problem.

24 JOHN COX: Appreciate it.

7 JUDY: Okay. Yeah. He'll know it, if you

8 say 'kins, I guess.

9 JOHN COX: Okay?

10 JUDY: All right. Appreciate it. You got

11 their phone numbers? Right?

12 JOHN COX: You betcha. You want to -- do

13 you have them off the top of your head? I've got your

14 mom's 608/635-4428.

15 JUDY: Yeah. I don't have my dad's off the

16 top of my head.

17 JOHN COX: I got it. 608/221-1775.

18 JUDY: Exactly.

19 JOHN COX: How's that?

20 JUDY: That's it. Okay.

21 JOHN COX: And you're feeling better?

22 JUDY: Yeah.

23 JOHN COX: Sounding pretty good.

24 JUDY: I feel fine. Tell them I feel fine.

25 JOHN COX: You sound pretty good.

1 JUDY: Yeah, we're just waiting to get this
2 all worked out.

3 JOHN COX: Hey, aren't we all.

4 JUDY: Yeah.

5 JOHN COX: Everything went well today from
6 what I can see and --

7 JUDY: You know what though, hey, that guy
8 was getting pretty obnoxious and aggressive towards
9 the end.

10 JOHN COX: Who's that?

11 JUDY: Byron.

12 JOHN COX: Why?

13 JUDY: On the, over the speakers. He was
14 like, I mean, David sent out 7 people, you know, were
15 apprehensive already to go out and then he is like a
16 tiger, I want 30 people out. We're going to mow down
17 the south side of -- you ran out (indiscernible) your
18 head up -- he didn't say that but that's what he
19 meant. And he was just screaming. Anyway. It was
20 kind of wild.

21 JOHN COX: It will all be over soon, won't
22 it, and I just wanted to tell you when Vicky came out
23 she was taken over to the Hillsboro Hospital.

24 JUDY: Oh, she was. Yeah. She seemed kind
25 of --

1 JOHN COX: They wanted to make sure that
2 they got, I guess, an IV in her and get some -- make
3 sure they got some liquids in her and take care of
4 her.

5 JUDY: Oh, yeah. She did not want to go out
6 at all.

7 JOHN COX: Well, from what David told me,
8 she had been pretty ill. You know, really bedridden.

9 JUDY: Yeah. She had some kind of high or
10 low blood pressure.

11 JOHN COX: She probably needs a pretty
12 complete physical so that's what she was getting.

13 JUDY: Okay.

14 JOHN COX: Better there than someplace else.

15 JUDY: Yeah.

16 JOHN COX: Yeah. Well, listen, I'm glad to
17 talk to you.

18 JUDY: Okay. Well, I've got somebody else
19 here for you too.

20 JOHN COX: Great.

21 JUDY: Okay. Appreciate it. Take care,
22 'bye.

23 ROSE: Hello John Number 1.

24 JOHN COX: Who's this?

25 ROSE: This is Rose. Maurice and Melissa's

1 mother.

2 JOHN COX: Hang on. Let me get the right
3 message here now.

4 ROSE: Okay. I'll hold the phone.

5 JOHN COX: I've got a stack of them.

6 ROSE: You have?

7 JOHN COX: Yeah. A bunch of different
8 people called in. Okay, I've got a message -- and
9 your name is Rose?

10 ROSE: That's right.

11 JOHN COX: You sound like you're a Brit.

12 ROSE: Pardon?

13 JOHN COX: You sound like you're a Brit.

14 ROSE: I do. Wow.

15 JOHN COX: This is from the British Vice-
16 Consul in Houston and it was a message to Melissa from
17 her grandmother and it's, in quotes, we are longing
18 for you to come out safely and to see you. I will
19 look after you. Your cousin, Nicola --

20 ROSE: Nicola.

21 JOHN COX: All I have is Nicola.

22 ROSE: Yeah.

23 JOHN COX: -- is anxious to see you. Love,
24 Grandma.

25 ROSE: Okay.

1 JOHN COX: Do you have any message that you
2 want delivered?

3 ROSE: Well, that she'll see her soon and
4 she is looking forward to seeing them too.

5 JOHN COX: Who is -- what's this?

6 ROSE: Melissa is looking forward to seeing
7 them all soon and she will do it and for them not to
8 worry. It is all written in the Book.

9 JOHN COX: Hang on, hang on. I'm trying to
10 write this down.

11 ROSE: Okay. -- seeing them soon.

12 JOHN COX: Okay.

13 ROSE: Say she's fine, she's great and --

14 JOHN COX: What did you say about the Book?

15 ROSE: Say not to worry what's happened,
16 it's written in the Book.

17 JOHN COX: Okay.

18 ROSE: So there's no concern for me there.
19 There's no concern for me there at all. Is that the
20 end of message.

21 JOHN COX: Yeah. And you're Rose's mom?

22 ROSE: Melissa's mom.

23 JOHN COX: I'm sorry -- you're Melissa's
24 mother. Okay. Now. Let me just -- I haven't talked
25 to you before, I have? Do you think I've talked to

1 you before?

2 ROSE: I don't think so, no.

3 JOHN COX: Okay. I'll pass that on and, how
4 old is Melissa, about 9, 10, something like that?

5 ROSE: No, 6.

6 JOHN COX: 6. Okay. Let me make something
7 perfectly clear to you, if you didn't already know it,
8 okay, because I haven't talked to you -- have you
9 talked to any of our fellows out here before?

10 ROSE: Well, yes.

11 JOHN COX: Do you know who you talked to?

12 ROSE: I think it was the other John.

13 JOHN COX: Okay. As long as, we just want
14 to make sure that you're doing well, you're healthy,
15 Melissa is doing well. She's healthy.

16 ROSE: Yeah.

17 JOHN COX: You don't have any medical
18 problems that we should be aware of?

19 ROSE: Not at all, no.

20 JOHN COX: That you are free to leave, and
21 it's strictly your decision not to leave.

22 ROSE: That is true.

23 JOHN COX: Okay, fine, and you understand
24 that, you know, if you want to leave --

25 ROSE: That I can do that at any time I

1 want.

2 JOHN COX: -- you can and you'll be cared
3 for. All you got to do is come down the road and
4 you'll get some medical attention and you'll get other
5 attention and take care of you.

6 ROSE: Yeah.

7 JOHN COX: I just wanted to make sure that
8 you understood that and you can rest assured that we
9 will make a contact with the British Consulate in
10 Houston because we've got the phone number and get the
11 word to them that not only is Melissa healthy but that
12 you are and we'll pass on what you said.

13 ROSE: Okay. Thank you very much.

14 JOHN COX: Okay. You take care of yourself.

15 ROSE: Sure. There's someone else who wants
16 to speak to you.

17 JOHN COX: Fine.

18 JUDY: Okay, 'bye-bye.

19 SANDRA: Hello.

20 JOHN COX: Hi.

21 SANDRA: Hi.

22 JOHN COX: Who is this?

23 SANDRA: This is Sandra. Sandra Hardial.

24 JOHN COX: Sandra. I haven't spoken to you
25 before.

1 SANDRA: No.

2 JOHN COX: Let me find the message that we
3 have for you. Boy, sounds like Steven has been out
4 working. Rounding everybody up. I have a message.
5 Lloyd Hardial called from Manchester, England -- and
6 I've got the phone number -- to enquire about you.
7 And he's your brother?

8 SANDRA: That's right. Yes.

9 JOHN COX: It doesn't say. That's why I'm
10 just trying to presume. And he said that your mother,
11 Una, sends her wishes that everything is all right and
12 that she loves you. And so, all I want to know is
13 there a message that you have to be returned, because
14 we have the phone number, 226-9550, and we'll be happy
15 to call Lloyd and give him a message if you have one.

16 SANDRA: All right. When will you be doing
17 that?

18 JOHN COX: Probably in the morning.

19 SANDRA: All right. Okay. --

20 JOHN COX: And we realize there's a time
21 difference over there.

22 SANDRA: Yeah, they're 6 hours ahead.

23 JOHN COX: Yeah, I've been over there
24 before,

25 SANDRA: Just say that I'm thinking of them

1 as well and just tell my mom that she's got to keep on
2 striving on with the weaknesses in her body and I'm
3 thinking (indiscernible) and my father --

4 JOHN COX: Hang on. Hang on. I can't write
5 too fast now.

6 SANDRA: Okay.

7 JOHN COX: Tell mom to --

8 SANDRA: Keep working on her legs.

9 JOHN COX: Okay.

10 SANDRA: I'm thinking of my brother and my
11 father.

12 JOHN COX: And you're thinking of your
13 brother and father.

14 SANDRA: Yes, and my auntie.

15 JOHN COX: And who?

16 SANDRA: My Auntie Joyce.

17 JOHN COX: Hang on. And Auntie Joyce.
18 Okay.

19 SANDRA: And lots of love.

20 JOHN COX: Pardon me.

21 SANDRA: Lots of love,

22 JOHN COX: Lots of love.

23 SANDRA: And that's it.

24 JOHN COX: Let me ask you something. All of
25 the people that we're contacting in there, first of

1 all, we want to make sure that you don't have any
2 medical problems that we should be aware of, or if you
3 do have some that we should be aware of, we would be
4 prepared to give you some medication, some treatment,
5 when you come out. Do you have any problems at all?

6 SANDRA: No, not whatsoever.

7 JOHN COX: Not on any medication or anything
8 like that?

9 SANDRA: No.

10 JOHN COX: Okay. And that you are in there
11 on your own free will and that you are aware that you
12 are free to leave anytime that you want and that we'll
13 welcome you right down the road.

14 SANDRA: Yeah.

15 JOHN COX: And you're aware of that.

16 SANDRA: Yeah, I am.

17 JOHN COX: Okay, fine. Anything else?

18 SANDRA: No, that's it.

19 JOHN COX: Anything I can answer for you?

20 SANDRA: I'm okay.

21 JOHN COX: Okay. I enjoyed talked to you.

22 SANDRA: Thanks very much.

23 JOHN COX: Bye-bye.

24 SANDRA: Bye.

25 * * * * *

1 (phone ringing)
2 JOHN COX: Hello.
3 STEVE: Hello, John.
4 JOHN COX: Hey. I thought you were down for
5 the count.
6 STEVE: Were you?
7 JOHN COX: No, I was in the other room.
8 STEVE: Oh, you were, okay. Yeah -- no, he
9 said he was in the other room. David's here, sitting
10 right by my.
11 JOHN COX: He is?
12 STEVE: Yeah.
13 JOHN COX: I thought he was asleep.
14 STEVE: He probably got a few winks. He
15 still looks tired, but, I doubt that he probably got
16 even that much.
17 JOHN COX: You sound like you just woke up.
18 STEVE: I was just laying down there for
19 just a few moments.
20 JOHN COX: Well, I got to talk to Sherry and
21 Judy and Melissa Morrison's mom, and Sandra Hardial.
22 So, that was nice.
23 STEVE: Good.
24 JOHN COX: Maybe talk to some of the others
25 tomorrow, I guess.

1 STEVE: Yeah, there -- apparently some must
2 have turned in already. I passed it out to a couple
3 of people to get it around so.

4 JOHN COX: Well, it was good to talk to some
5 of them.

6 STEVE: Yeah, David, he's got a couple of
7 questions for you, I think.

8 JOHN COX: Okay.

9 STEVE: Here he is.

10 JOHN COX: All right.

11 DAVID: Did you get a good night's rest?

12 JOHN COX: Well, a good day's rest.

13 DAVID: A good day's rest.

14 JOHN COX: Yeah. Start losing track of
15 night and day.

16 DAVID: Yeah, we tried to sleep a little bit
17 the day after going all night with these people and,
18 of course, I kept dreaming about having this radio on
19 all day long.

20 JOHN COX: I thought you dreamt about
21 meeting me down that road.

22 DAVID: No, not yet. It's coming.

23 JOHN COX: Good.

24 DAVID: Do us a favor.

25 JOHN COX: Yes, sir.

1 DAVID: It's very distracting, you know, I'm
2 fixing to go to another session with some people who
3 will be out in the morning and, do me a favor, see if
4 you can get John Dolan and these guys to kind of cut
5 that radio out. We've heard it. We've heard each one
6 of those things at least, what eight or nine or ten
7 times, or. I mean, you know, it's more effective for
8 these people to get the last of these scriptures down
9 than it is to hear what they've already heard over and
10 over again. We haven't yet found the book of John
11 Dolan in the scriptures yet. So --

12 JOHN COX: Not yet, huh.

13 DAVID: John -- is it John-3?

14 JOHN COX: Who, me?

15 DAVID: No, no. -- oh -- this one guy you've
16 got there. What's his last name, Steve. John-3, I
17 mean, he's a finger up the gill, you know what I mean.

18 JOHN COX: What's he do, strike a nerve or
19 something?

20 DAVID: I mean --

21 JOHN COX: I've never heard that one before.

22 DAVID: This guy seems to -- it's hard to
23 explain.

24 JOHN COX: Uh-huh. He's a good ol' boy
25 though.

1 DAVID: I don't know.

2 JOHN COX: Maybe you're just taking him the
3 wrong way. You don't know?

4 DAVID: Well, that's serious if we take him
5 the wrong way.

6 JOHN COX: It is, it is. He's well meaning
7 though.

8 DAVID: Oh, well.

9 JOHN COX: You going to be up tonight then?

10 DAVID: Yeah, all night long. Just like
11 last night.

12 JOHN COX: Okay. Okay.

13 DAVID: See if you can't have him back in
14 the back getting refreshments for you all. We don't
15 want to talk to him no more.

16 JOHN COX: Okay. Let me talk to some folks
17 and I guess you're going to be talking to some folks.

18 DAVID: You and Dolan, you know, we'll work
19 this out. I'll personally put in a statement that I
20 want y'all guys to get a raise.

21 JOHN COX: Oh, terrific.

22 DAVID: But, you know, like I said, we must
23 have our understanding and if we don't have that, like
24 I said, it's going to be catastrophe. I can't
25 understand that, okay, if the President was to send

1 you overseas on a mission, right, you know, a serious
2 FBI mission, and you know, you're dealing with another
3 nation, other laws and all this kind -- it's top
4 secret, all right. He has to brief you the last few
5 steps before you go, right?

6 JOHN COX: Um-hum.

7 DAVID: Okay, so the thing of it is that,
8 you know, that is a very serious matter for you as an
9 FBI agent considering everything that is involved. So
10 the same as here. You know, we don't just teach the
11 good ol' Gospel, you know, the old four square thing
12 you've heard for years and years. You know, the
13 fields are more in depth than that. And, you know,
14 we've been talking about it. I don't want to belabor
15 the issue here tonight.

16 JOHN COX: Sure. Yeah. You got me last
17 night. Didn't you.

18 DAVID: Well, no. The thing of it is, is
19 that we're both gotten. Aren't we?

20 JOHN COX: Sure.

21 DAVID: I mean. We both stand before the
22 same Father, don't we?

23 JOHN COX: Well, I want to give you the
24 opportunity to do what you want to do this evening, or
25 this morning, or --

1 DAVID: What I've got to do so that we can
2 get more people out to you.

3 JOHN COX: Sure.

4 DAVID: How did Rita, how did Rita act when
5 she came around? Was she nervous?

6 JOHN COX: Well, I didn't see her.

7 DAVID: Oh, you never got to see her.

8 JOHN COX: No, I didn't see her when she
9 came out and as far as I know, everybody came out and
there wasn't any problems and everything worked well.

10 DAVID: Well, those five people that came
11 out today, that's on your credit. Don't put the stars
12 next to John-3's name. He didn't do -- as a matter of
fact, he almost hindered it.

13 JOHN COX: We all share. We all share.
14 We're all part of the same big team.

15 DAVID: You caught the fish on that one.
16 Don't tell no fish stories.

17 JOHN COX: We're all part of the same team.

18 DAVID: All he brought back home was the
19 bait on his hook. I mean, that's -- let's be real. I
mean, the guy needs to go back to school.

20 JOHN COX: Well, we have different
21 personalities but we have the same purpose in mind, to
22 get things done and --

23

1 DAVID: Well, so do I. So do I. But you
2 guys can't fight amongst yourselves over there, can
3 you?

4 JOHN COX: We try not to.

5 DAVID: Okay. So we can't -- so if I'm
6 going to be on your side too, to the degree that
7 you're trying to obtain the same purpose, then I can't
8 be fighting with y'all either.

9 JOHN COX: Well, let me talk to some people
10 and I'll give you a call back.

11 DAVID: All right. And if you want to call
12 back and get in on the study, you're more than welcome
13 to.

14 JOHN COX: I hear you.

15 DAVID: Okay. All right. Thanks, John.

16 JOHN COX: Sure.

17 DAVID: Bye.

18 JOHN COX: Bye

19 * * * * *

20 JOHN COX: Hello.

21 STEVE: Hello, John.

22 JOHN COX: Hey Steve.

23 STEVE: I can't even keep a straight face
24 here. Listen to this. Of course it's -- sounds like
25

1 a Catholic monastery or something.

2 JOHN COX: What is it?

3 STEVE: Well, your friends are playing some
4 unique music here. I suppose now it's going to be a
5 psychology game or something.

6 JOHN COX: It's over the --

7 STEVE: They must have borrowed this from
8 Siberia.

9 JOHN COX: -- PA system?

10 STEVE: Yeah.

11 JOHN COX: Is it music or voices or what?

12 STEVE: You know what it is, of course. You
13 were there when they chose it, I'm sure, but, anyway -
14 -

15 JOHN COX: I'm not out there privy to what's
16 going on out there.

17 STEVE: Let me just share something with
18 you?

19 JOHN COX: Uh-huh.

20 STEVE: After all these years of studying
21 all these religions, listening to the philosophies of
22 men, in the Bible, in Isaiah 65, it talks about a
23 hundred-year period where those that don't do God's
24 way in the final days, they take the mercy that's
25 offered by all the prophets, what they stated. They

1 get to live a hundred years of no intercession of God,
2 no holy angels, all the thoughts of men, they will do
3 unto each other whatever comes into the minds of men.

4 The tides of evil will not be held back. Chapter 66
5 gets into more detail. All the nightmares, all the
6 things that men have created through their existence
7 on this earth becomes a reality for them. This kind
8 of thing that they're playing for us right now,
9 Halloween will become a reality for hundred years and
10 men can't die to get away from it. So you know, what
11 is happening to us now, we accept it. We probably
12 deserve it because of our lives, but at the same time,
13 I'm telling you the truth, you know, it'll become a
14 reality for people for a hundred years.

15 JOHN COX: Well, the only thing I can do is
16 pass on what you're telling me. And let --

17 STEVE: Okay. You know, whatever comes, you
18 know, it's fine. Really, it's fine. My concern is
19 not for myself, here now, not in the flesh. My
20 concern is for people that are involved in this kind
21 of thing right here. This country of America that
22 I've loved all my life, like all the prophets talk
23 about. The one great nation. A merchandizing nation
24 in the final days. Very powerful. Very strong.
25 Based on freedom of speech, religion, all that. It's

1 going to repudiate those values and it's going to be
2 brought down as an example to all the world. It's not
3 something I chose, something I like, but it's in the
4 prophecies and it's all called Assyria, but there was
5 no Assyria in the days of Ezekiel. It had long passed
6 away in 620 B.C. and Ezekiel wasn't written until 570
7 B.C. So a nation in the final days has an eagle as
8 it's symbol that overspreads the lands. So we're
9 finally here. It's the most powerful nation on earth
10 but all the prophets talk, in the final days, what's
going to happen to this nation, so highly blessed.

11 JOHN COX: Steve, can you tell me something
12 that would facilitate me convincing some people to
13 knock off what is going on now. I mean, I can try.

14 STEVE: What are you suggesting? I don't
15 mind --

16 JOHN COX: I'm not suggesting --

17 STEVE: If they'd like, they can turn it on
18 louder and leave it on morning, noon and night. I
19 mean, it won't have any effect other than people --
20 it's just going to ruin my opportunity --

21 JOHN COX: I talked to David, you know, and
22 he said --

23 STEVE: He just told me now. Just right
24 now. He said no one is coming out. Nobody.

1 JOHN COX: Yeah. Well, I talked to him
2 earlier and he -- about, I guess there were some
3 recording on then and he said, you know, we've heard
4 the recordings nine or ten time, or whatever and see
5 if you can get somebody to turn them off. I was going
6 to check on that and then you called and said it's not
7 recordings, it's something else on now, so --

8 STEVE: Yeah.

9 JOHN COX: So all I can do is go talk to
10 people --

11 STEVE: There is --
